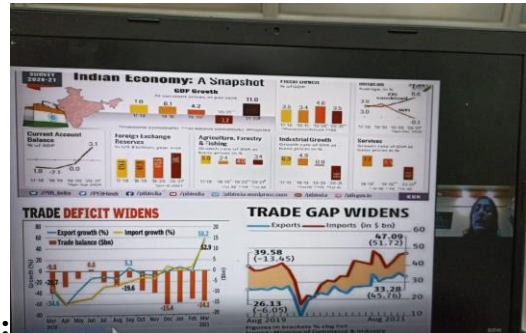
1. The objective of organizing this workshop is to make students understand the concept Budget and Taxation.

## 8. Outcome of the event:

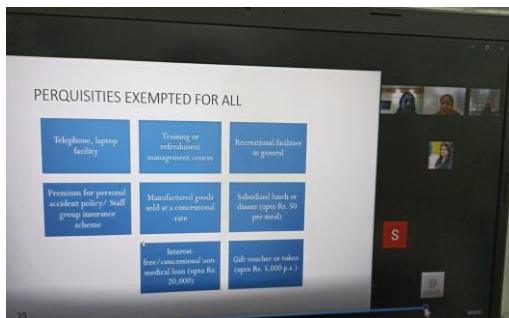
